## **Application Procedure for Military Family Membership**

In order to be considered for Military Family Membership into the Tiverton Rod and Gun Club (TRGC) applicants must:

1. ***Complete the Family Membership Application included in this packet.*** Primary applicants must be considered “active duty” in any of the US Armed Services and must provide proof of enlistment and Secondary applicants must be at least 18 years old and able to possess a firearm per RI and federal laws.
2. ***Complete a State Bureau of Criminal Identification (BCI) check for the “secondary” adult through your Attorney General’s Office or District Attorney’s office if the “secondary” adult is not active duty.*** This usually can be done through the mail or in person. Please consult your Attorney General’s Office (RI) or District Attorney’s Office (MA) for further information. Exclusions to this requirement include a current military id or a resident firearm carry permit.
3. ***Bring your completed membership paperwork and “New Military Family Membership” dues payment (see dues schedule on page 2) to any New Member Orientation.*** New Member Orientations are held on the fourth Wednesday of each month at 7 pm. Payments must be made by credit card, check, or money order and are payable to the Tiverton Rod and Gun Club. Applications will be voted on at the next regularly scheduled association meeting held on the first Thursday of every month. TRGC reserves the right to delay or deny membership for any reason. The “New Military Family Membership” dues payment will be refunded, excluding the initiation fee, if the applicant is rejected for membership into TRGC.

### **General Membership Policy**

Applicants must complete this membership packet and attend a New Member Orientation before they will be considered for membership. All members are encouraged to get involved in club activities.

### **Military Family Membership Policy**

The Military Family Membership consists of a primary adult (who may obtain voting privileges) and a secondary adult (who is considered “honorary”) that live in the same household. The Military Family membership also includes an unlimited number of children (under the age of 18) who must be listed on the Military Family Membership Application. Children may remain under family membership until their eighteenth birthday and must be accompanied by an adult while on TRGC property. Military members must provide proof of enlistment before any dues renewal period. Military Members are exempt from paying dues while out of state or country where previous notice has been given. ### **New Membership Dues Policy**

If an applicant’s initial membership occurs from January through June, a full “New Military Family Membership” rate applies which includes an initiation fee. If an applicant’s initial membership occurs from July through October, a fifty percent “New Military Family Membership” rate applies which includes an initiation fee. If an applicant’s initial membership occurs from November through December, the applicant will be considered as paying dues for the following year and a full “New Military Family Membership” rate applies which includes an initiation fee. ## Bureau of Criminal Identification Request Information

### BCI Requirement:

The Tiverton Rod and Gun Club (TRGC) requires all "secondary" adult military family applicants to submit a BCI check with their "New Military Family Membership" packet or a Concealed Carry Weapons permit from their state of residence. TRGC follows all RI laws pertaining to the possession of a firearm. The Membership Committee will examine an applicant's BCI form to ensure the applicant has not committed a "Crime of Violence" which would preclude them from owning a firearm.

Per RI law a "Crime of violence" means and includes any of the following crimes or an attempt to commit any of them: murder, manslaughter, rape, first or second degree sexual assault, first or second degree child molestation, kidnapping, first and second degree arson, mayhem, robbery, burglary, breaking and entering, any felony violation involving the illegal manufacture, sale, or delivery of a controlled substance, or possession with intent to manufacture, sell, or deliver a controlled substance classified in schedule I or schedule II of § 21-28-2.08, any violation of § 21-28-4.01.1 or 21-28-4.01.2 or conspiracy to commit any violation of these statutes, assault with a dangerous weapon, assault or battery involving grave bodily injury, and/or assault with intent to commit any offense punishable as a felony; upon any conviction of an offense punishable as a felony offense under § 12-29-5. (from RI General Laws)

**NOTE:** The Tiverton Rod and Gun club does not file BCI forms. The forms will be returned to the applicant after the Membership Committee's one month examination period.
